WATER SYSTEM INFORMATION:

This report shows our water quality and what it means. If you have any questions about this report or concerning your water utility, please contact Tobias Krajcirik at 570-645-3040. We want you to be informed about your water supply. If you want to learn more, please attend any of our regularly scheduled meetings. They are held on the fourth Wednesday of each month at 3:45 pm at the Authority Office, One East Ridge Street, Lansford, PA 18232.

SOURCE(S) OF WATER:

Our water source consists of eight (8) ground water wells ranging in depth from 230 to 650 feet; they are located in the Lake Hauto section of Nesquehoning. The water is pumped to a wet well and then to our chemical treatment plant, where it is treated and then stored in one of our two storage tanks located at the top of the Hauto Mountain. Combined, our water storage tanks hold more than 2 million gallons of treated water.

The Authority continued to perform general maintenance of the water system in 2021. In June, 2021, the Authority performed a Risk and Resilience Assessment of the water system with the assistance of the Pennsylvania Rural Water Association in accordance with requirements set forth by the United States Environmental Protection Agency (EPA). In December, 2021, the Authority updated their Emergency Response Plan with the assistance of the Pennsylvania Rural Water Association as required by EPA. On August 13, 2021, a new meter was installed at Well A. The Authority continued to perform leak detection of the water system using equipment purchased in 2018 to find leaks and reduce water loss.

A Source Water Assessment was completed by the PA Department of Environmental Protection (PADEP) in December, 2003. The Assessment found that our source is potentially susceptible to commercial and industrial contamination. Overall, our source has a high risk of significant contamination. Some people may be more vulnerable to contaminants in drinking water than the general population. immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. MONITORING YOUR WATER:

We routinely monitor for contaminants in your drinking water according to federal and state laws. The following tables show the results of our monitoring for the period of January 1 to December 31, 2021. The State allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data is from prior years in accordance with the Safe Drinking Water Act. The date has been noted on the sampling results table.

DEFINITIONS:

Action Level (AL) - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level (MCL) - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Minimum Residual Disinfectant Level (MinRDL) - The minimum level of residual disinfectant required at the entry point to the distribution system.

Treatment Technique (TT) - A required process intended to reduce the level of a contaminant in drinking water.

Mrem/year = millirems per year (a measure of radiation absorbed by the body)

ppm = parts per million, or milligrams per liter (mg/L)

pCi/L = picocuries per liter (a measure of radioactivity)

ppq = parts per quadrillion, or picograms per liter

ppb = parts per billion, or micrograms per liter (pg/L)

ppt = parts per trillion, or nanograms per liter

The Pennsylvania Department of Environmental Protection (DEP) detected five (5) observations and violations in 2021 for Lansford-Coaldale Joint Water Authority listed below:

Haloacetic Acids (Five)- The Notice of Violation was received on 10/21/2021 for Failure to Monitor or Report for the Disinfection/Disinfection Byproduct Contaminant. Samples were collected on 11/11/2021 and analyzed. The LCJWA collected samples as required and submitted the report late to achieve compliance. The sample results were within the Maximum Contaminant Level. A Public Notice was issued explaining the sampling error.

Trihalomethanes- The Notice of Violation was received on 10/21/2021 for Failure to Monitor or Report for the Disinfection/Disinfection Byproduct Contaminant. Samples were collected on 11/11/2021 and analyzed. The LCJWA collected samples as required and submitted the report late to achieve compliance. The sample results were within the Maximum Contaminant Level. A Public Notice was issued explaining the sampling error.

Revised Total Coliform Rule (RTCR)- There were three (3) Notice of Violations related to this. The first Notice was on 10/21/21 for Failure to Conduct a RTCR Level 1 Assessment. The second Notice was on 10/21/21 for Failure to Notify DEP within 1 hour of RTCR Treatment Technique Violation/Corrective Action Complete. The third Notice was for Failure to Issue a Tier 2 Public Notification. The LCJWA issued a Public Notice and the LCJWA collected samples as required and submitted the report late to achieve compliance. All of the above-mentioned violations were for reporting issues and did not affect the quality of your water.

EDUCATIONAL INFORMATION:

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater run-off, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

Information about Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Lansford-Coaldale Joint Water Authority is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
